Master of Science in Law: Where Global Business, Law & STEM Converge

Northwestern University's Master of Science in Law (MSL) integrates the study of law, regulation, business, and policy into a curriculum for STEM-focused students and professionals. Offered by the Pritzker School of Law, the MSL arms its students with a powerful set of skills and knowledge that allows them to solve multifaceted problems and succeed in today's complex global business environment.

MSL graduates go on to become leaders in their fields. They are prepared for a variety of intersectional roles in business and policy settings and are greatly sought after for their holistic approach to solving problems, the mindset to anticipate challenges and assess risk, and the ability to communicate and interact across disciplines.

Curriculum

Centering on the intersection of law, business, and technology, the MSL curriculum offers courses in business and entrepreneurship, intellectual property, regulatory analysis, and skills development. Areas covered include healthcare, privacy, finance, data security, technology & AI, compliance, contracts, environmental law, biotechnology, and pharma.

Community

MSL students benefit greatly from studying law at one of the world's leading law schools, where they have access to renowned faculty and a highly successful alumni base, in addition to broader Northwestern University resources. MSL students are an integral part of the Northwestern Pritzker Law community: they collaborate, network, and socialize with JD and LLM students, and participate with them in various law school activities.

Career Development

The MSL program provides comprehensive professional development support, including one-on-one career advising and numerous programs and activities designed to help MSL graduates chart a productive path. International graduates have the option to pursue OPT training in the US for at least 12 months; those who have an undergraduate STEM degree from a US university may be eligible for the 24-month OPT extension.

Application Process


Applicants to the MSL submit an online application, which includes a statement of interest, a resume, a video interview, a letter of recommendation, and transcripts from all post-secondary institutions (can be unofficial at the application stage). International students submit a TOEFL or IELTS score, or they can request a waiver from the Admissions Committee. Applicants whose first language is not English participate in a live interview.
