
# School Leaving Procedure Notices for Bachelor/Master/Doctor Program Graduates

- 1. Please review if there's anything undone at the "School Leaving Procedure System" after December 16<sup>th</sup>, 2024. (Located in your student information system.)
  - A. Grades/Scores are all recorded over your years of study, and have met the graduation threshold.
  - B. Confirmation of every unit related to the school leaving procedure. (Each department, Library, Cashier Section, International Affairs etc.)
  - **XTo return books to the Library**, in person, through book drop or with registered mail. (Please note "Return" on the envelope).
  - \*\*Confirmation from the Center of Comparative Law Documentation/ Reference & Extension Services Section of Library are excluded for Bachelor degree students.
- 2. All graduates should finish the school leaving procedure before February 14<sup>th</sup>, 2025.

# [Notes]

- 1. Office hour during summer break: Monday to Friday from 9:00 A.M. to 4:00 P.M.
- 2. Graduates should complete the school leaving procedure before February 14<sup>th</sup>, 2025 to avoid any influence on further education.
- 3. Students who is in urgent need of graduation certificate, please take note to go through the process early.
- 4. Student Information System and E-learning Academy 2.0 and 3.0 accounts will be deactivated after the graduation certificate was collected. Kindly back up all of the information for further references if needed.
- 5. Before leaving school, students who still is the school part-time assistant should go through the contract termination process in each responsible unit. (Personnel Division, Office of Academic Affairs, Office of Student Affairs, Office of Research and Development Affairs).
- 6. A trial run of the digital diploma will be conducted this semester. The digital diploma will be mailed to the emailbox listed in the student information system within 3 working days after the paper degree certificate is collected. Please confirm that the email address in the student information system is correct(please go to the system→menu→Enrollment Status →Change of personal profile→Contact Information). If you need to change your email address, please complete it before school leaving procedure.
  - I. Please download the digital certificate by "Download Attachment" instead of "Print->Save New File", which will cause the certificate file encoding to be modified and cannot be verified.
  - II. When changing the file name of a digital certificate, do not use the symbol "." (dot) to prevent the system from interpreting the file format incorrectly.
  - III. How to verify a digital diploma? You can provide your own digital files, as well as the website of the Digital Diploma Verification System of the Ministry of Education to outside institutions for degree verification. The attached picture is as follows:
